# RESOLUTION ADOPTING FINAL PLAT OF REED HILL SUBDIVISION

WHEREAS, Jewett Holmwood LLC (hereinafter referred to as the "Applicant"), has applied for final plat approval for the subdivision of property for one-family residences located on Jewett Holmwood Road in the Town of Aurora, and

WHEREAS, pursuant to Section 99-7 of the Town of Aurora Code, a preliminary plat was previously submitted and approved by the Town Board, and

WHEREAS, the applicant has applied for approval of a final plat pursuant to Section 99-8 of the Town Code, and

WHEREAS, in compliance with Section 99-8(A), the applicant has complied with the terms and provisions of the said section, and

WHEREAS, the Town of Aurora Planning Board has submitted its report of recommendations in writing to the Town Board regarding approval of the final plan, and

WHEREAS, the Town Board has received various traffic studies submitted by the applicant, and has also received communication from Erie County's Traffic Safety Engineer who has reviewed those reports and has concluded that the access road location is acceptable, which representations the Town Board has relied upon in consideration of the final plat approval, and

WHEREAS, on September 26, 2011, the Town Board held a public hearing on the final plat, at which time the Applicant submitted an Affidavit stating the names and addresses as notified by certified mail, return receipt requested, of each owner of property within 500 feet of any boundary of the subdivision, and

WHEREAS, pursuant to Section 99-8(E) of the Town of Aurora Code, the approval of the final subdivision plat shall expire two (2) years after the date of the Resolution granting conditional approval unless all requirements have been completed as provided by the said section, and

WHEREAS, no final approval will be endorsed on the plat until a review has indicated all requirements of the Resolution have been met, and

WHEREAS, the approval of the final plat is conditioned and based upon all of the documents submitted by the Applicant and others incorporated into this Resolution by reference.

NOW, THEREFORE, be it

RESOLVED, the Town Board of the Town of Aurora does hereby grant approval of the final plat submitted by Jewett Holmwood LLC for the Reed Hill Subdivision (formerly known as Jewett Holmwood Subdivision), subject to the terms, provisions and conditions set forth by the Town Board, and be it further

RESOLVED, that there shall be compliance with all terms, provisions and conditions set fourth herein or included by reference for this final plat approval, and be it further

RESOLVED, upon review by the appropriate officers of the Town, the Town Board shall endorse approval on the plat after all conditions of the Resolution have been satisfied and all improvements satisfactorily completed or bonded, and be it further

RESOLVED, it shall be the responsibility of the Applicant to file the final plat in the Erie County Clerk's office within sixty (60) days of the date of signature and to provide a copy of the filed plat to the Town Clerk.
