TOWN OF AURORA LOCAL LAW NO.2-2024

A LOCAL LAW, TO AMEND LOCAL LAW 1-1990 KNOWN AS THE CODES OF THE TOWN OF AURORA, ADOPTED BY THE TOWN BOARD OF THE TOWN OF AURORA ON JANUARY 22, 1990, BY AMENDING CHAPTER 55, ARTICLE II, SECTION 55-10 TO INCREASE OVERNIGHT IMPOUNDMENT FEES.

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF AURORA AS FOLLOWS:

SECTION 1. LEGISLATIVE INTENT

This Local Law is intended to increase fees charged for the overnight impoundment of dogs in order to reflect the rising costs incurred by the Town for the provision of such service.

SECTION 2. <u>SECTION 55-10 IMPOUNDMENT FEES.</u>

Section A(5) shall be amended to read as follows:

(5) In addition to the fines described herein, the owner of any impounded dog will be required to pay \$40 for each 24 hours or part thereof said dog is impounded.

SECTION 3. SEVERABILITY.

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by

any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

SECTION 4. <u>EFFECTIVE DATE</u> This Local Law shall take effect immediately upon filing with the New York Secretary of State.
