### Closure:


That portion of Emery Road (CR 67) from Center Road to Lewis Road will be closed for the replacement of a cross culvert east of 1685 Emery Road. This closure will begin on September 24, 2018 at 8:00am and will end on September 28, 2018 at 4:00pm, or until complete. Detours will be in place utilizing Center, Darien, and Lewis Road. The contractor for this project is Hunting Valley.

This restriction is executed under Article V, Section 104A of the Highway Law in order to permit a proper completion of work of improvement thereon.
