WHEREAS, the Town of Aurora is a Town of the first class, and

WHEREAS, the Town of Aurora established a Master Water Improvement Area dated September 12, 2016 which was recorded in the Erie County Clerk's Office on September 15, 2016 in Book 11301 of Deeds at Page 9492, and

WHEREAS, with the establishment of a Master Water Improvement Area, all of the assets in the involved Water Districts were transferred by deed and assignment of easements to facilitate such assets to the Erie County Water Authority, and

WHEREAS, the Office of the State Comptroller, Department of Audit and Control reviewed the application for the establishment of the Master Water Improvement Area on August 22, 2016 at which time the State Comptroller issued an order that such application of the Town Board of the Town for permission to establish the Master Water Improvement Area was approved, and

WHEREAS, New York Town Law Subsection 2 requires that upon the adoption of this resolution to convey real property in the name of the Town, which resolution is subject to a permissive referendum, and

WHEREAS, the proposed transfer of real property by deeds and assignment of easements from the Town of Aurora to the Erie County Water Authority is a requirement for the proposed Direct Service Agreement whereby the Erie County Water Authority would assume complete ownership and management of the Master Water Improvement Area, and its assets including the real estate by deeds and assignment of easements,

NOW, THEREFORE, be it

RESOLVED, that the Town Board does hereby approve the transfer of the real property owned by the Master Water Improvement Area by real property deeds and assignment of interests to the Erie County Water Authority upon approval of the Direct Service Agreement which transfer is subject to permissive referendum by the provisions of Town Law § 64 (2) and § 92, and be it further

RESOLVED, that pursuant to Sections 82 and 90 of the Town Law that within ten days from the date of this resolution the Town Clerk shall post and publish a notice which shall set forth the date of the adoption of the resolution, shall contain an abstract of such resolution concisely setting forth the purpose and effect thereof, shall specify that this resolution was adopted subject to a permissive referendum; and shall publish such notice in the East Aurora Advertiser, a newspaper published in Erie County having general circulation in the Town of Aurora, and in addition thereto the Town Clerk shall post or cause to be posted on the sign-board of the Town of Aurora, a copy of such notice within ten (10) days after the date of the adoption of this resolution.
