A meeting of the Town Board of the Town of Aurora took place on Monday, March 25, 2019 at 7:00 p.m. in the Town Hall Auditorium, 300 Gleed Avenue, East Aurora, New York.

Deputy Supervisor Snyder opened the meeting at 7:00 p.m. with the Pledge of Allegiance to the Flag.

The first item on the agenda was a PUBLIC HEARING on the request from Gregory Schneider for a special use permit for a private four (4)-site campground at 686 Quaker Road. Deputy Supervisor Snyder opened the hearing at 7:02 p.m. and asked if anyone wished to comment.

Mary Parker, Quaker Road, spoke against the proposal citing the following concerns: decrease in her property value, setting a precedent for other vacant or large lots along Route 20A, sanitation/garbage, and headlights exiting the property would be directly into her living room.

Carol Rockhill, Quaker Road, directly next door, stated she is not in favor of the project because two of her bedrooms are on the side of her house facing the campground. Smoke from campfires would be bothersome. Noise from generators would be disturbing. Mrs. Rockhill expressed concern in being able to sell her house if it was next to a campground.

Shane and Andrea Thorn, Grover Road, are concerned with decrease in property value, opening the door to other activities on the property, expansion of the campground, general safety in the neighborhood and what would happen if the property were sold to someone else.

Janice Moffet, Quaker Road, stated it should not be in this neighborhood as the residents put a lot of money into improving their homes and it is a residential neighborhood.

Sheila Brody, Oakridge, spoke against the proposal noting that she is concerned about the safety of people walking on Route 20A, Grover Road and Oakridge. She is concerned that campers will start exploring the area and end up on private property, noting there is a cliff behind some of the homes on Oakridge. Mrs. Brody stated that there are elderly people living at the Trinity apartments to the west of the Mr. Schneider's property and she is concerned for their safety and well-being.

David Romanczak, Oakridge, stated he is not in favor of the project because it sets precedence for future campgrounds on Route 20A, property values will go down, the entrance to the campground is close to Grover Road and Route 20A often has heavy traffic flow.

Arlene Kroh, Oakridge, stated she agrees with everything that has been said so far.

Liz Riemer, Grover Road, stated she is not in favor of the campground. She noted that property values will go down, she is worried about security in the area – especially for the senior residents at Trinity apartments, it would set precedence for other campgrounds, strangers are not "invested" in the area and she does not want a "Woodstock" camping occurrence especially with all the music festivals in the East Aurora area.

Hearing no further comments, Deputy Supervisor Snyder closed the hearing at 7:22 p.m.
