Supervisor Bach opened the special meeting at 10:00 a.m.

NEW BUSINESS:

During the demolition project at the Aurora Municipal Center, it was discovered that a section of roof was built through a block wall. When the roof was removed, it left a hole that needs to be repaired. It was also realized that an existing catch basin in the parking lot at the site is at an elevation that will not work with the parking lot and entrance sidewalk grades. Telco Construction has submitted change order requests for the work.

Councilwoman Friess moved to approve change order no. 3 from Telco Construction, Inc. for additional cement block work to infill the wall where the gypsum roof deck intersected it at the Aurora Municipal Center project at 575-587 Oakwood Ave., and to authorize the Supervisor to sign the change order in the amount of \$4,648.00:
