Supervisor Bach opened the meeting at 7:00 p.m., noting that Councilman Snyder will not be at this meeting as today is the last day of his quarantine after traveling out of state.

The first item on the agenda was a Public Hearing on a Special Use Permit request from Jyl and Ricardo Rivera to hold events at 1897 Davis Road, PO West Falls, NY. The notice was published in the East Aurora Advertiser and posted on the Town Clerk's bulletin board as noticed by the Affidavits of Publication and Posting.

Supervisor Bach opened the hearing at 7:04 p.m., and asked if anyone in the audience wished to be heard on this application.

Doug Crow, Davis Road, stated they are good neighbors and is in favor of the proposal. Jyl Rivera read three letters of support from 1) neighbor at 48 Bridge Street; 2) neighbor at 1905 Davis; and 3) the owner of 1887 Davis Road.

Hearing no other comments, the Supervisor closed the hearing at 7:08 p.m.

Councilwoman Jeffe stated she visited the site and stated the parking lot needs to be striped. Mrs. Jeffe also noted her concerns about having porta-potties for restrooms, the exit onto Davis Road and people crossing Davis Road if they have to park off-site. Mrs. Rivera stated that they and their employees are the ones that park off-site. Mr. Rivera stated they are in line to purchase 1887 Davis Road that could be used for more parking and an alternate exit.

Councilwoman Jeffe asked how the number of people is controlled for an event. Mrs. Rivera stated that due to Covid 19, they are limited to 50 people and all are by reservation.

Councilwoman Friess stated she is concerned with the number of people. Bill Kramer responded that their parking lot has 53 spots (plan submitted shows 34 parking spaces), Town Code figures 4 people per vehicle, so there could be approximately 200 max per event.

After further discussion, Supervisor Bach stated the Town would need to draft a resolution listing all the conditions the Town wants to have on the permit. It could be renewed annually. Councilwoman Friess stated if we get stuck on details, the Town could possibly look at a short-term permit and then revisit it.

Supervisor Bach explained to the applicants that this will not be considered tonight, but will be put on the August 10, 2020 meeting agenda for consideration.

Councilwoman Jeffe stated this is outdoors, people will be spread out and baseball is approved by NYS guidelines.

Councilwoman Friess asked who enforces social distancing, etc. Mr. Mersmann responded that he, the organization president and league volunteers do the enforcing.
