ADMINISTRATIVE:

Reports:

- We have 14,526 members registered in our recreation system
- We had 45 individual program registrations in the month of November
- We generated \$1,951 in sales for November
- Credit card purchases totaled 86% (73% on-line, 17% office)
 - 2019 to 2021 comparison:

▪ Total sales from 1/1/2019 – 11/30/2019	\$203,182
▪ Total sales from 1/1/2020 – 11/30/2020	\$130,101
▪ Total sales from 1/1/2021 – 11/30/2021	\$185,939

The number of positive COVID cases has seen a significant increase in Erie County. As a result, we have instructors that are waiting to run their programs until it is safer and reduced registrations for the programs we are running. With everything going on we, are still very happy to be able to run many of our normal programs like bowling and wrestling.

Winterfest preparation has begun! We have reached out to our local businesses to begin planning for a week of fun in February. We also have some safe activities that we will be running.

EAST was able to run it our annual Kiwanis meet in early November. We had just under 300 swimmers attend over the course of 3 different sessions. Our team and volunteers took every precaution to keep everyone safe. EAST continues to practice 5 days a week at the high school servicing just over 70 athletes.




