Supervisor Bach opened the meeting at 8:15 p.m., immediately after the work session.

The Supervisor gave a PowerPoint presentation on the 2023 Budget. Mr. Bach spoke about the various Town funds and gave a tax rate summary, noting that the tax cap is not actually 2%, but is based on a formula given to the Town by the State. The General (A) Fund rate will be \$3.79/\$1000av - an increase of \$0.14/\$1000av; Part Town (B) Fund rate will be \$2.71/\$1000av – an increase of \$0.03/\$1000 av; Highway Townwide (DA) Fund rate will remain the same at \$0.11/\$1000av; and the Highway Town only (DB) Fund will remain the same at \$1.58/\$1000av.
