

February 24, 2025

A meeting of the Town Board of the Town of Aurora took place on Monday, February 24, 2025, beginning at 6:30 p.m. The Board met in-person at the Aurora Municipal Center, 575 Oakwood Avenue, East Aurora, New York. The meeting was streamed via YouTube.

Supervisor Snyder opened the meeting at 6:30 p.m. with the recitation of the Pledge of Allegiance to the Flag.

The first item on the agenda was a public hearing on a request for a Special Use Permit for a Dwelling Group (two or more dwellings on a parcel) at 145 Reiter Road, East Aurora, NY. Supervisor Snyder opened the hearing at 6:31 p.m. and asked if anyone wished to comment.

Daniell Johnson of Crafted Concepts Architecture, agent for the applicant Kathleen Miller, spoke to the Board about the proposal. Ms. Johnson stated that they are fitting out the second floor of an existing structure with a 1300 square foot apartment with three bedrooms and one bathroom. The proper setbacks exist if the dwelling were to be split from the larger parcel. Ms. Johnson said that the apartment will be used by the caretaker of the property. The parcel is 71 acres and includes a residence, a horse barn and a cow barn.

Code Enforcement Officer Cassidy stated this is a separate building from the house and it meets the Code requirements for a dwelling group. Hearing no further comments, the Supervisor closed the hearing at 6:36 p.m.

Code Enforcement Officer Cassidy stated that in January 2025 the NYSDEC freshwater wetlands regulations changed.

Rod Simeone, ZBA members, asked about the status of the proposed change to the Town Code regarding in-law apartments. The response was that the finalized version needs to go back to the review committee and then to the Town Board, Town Attorney and possibly the Planning Board.
