General Information

- Our reconfiguration of the department is moving along well. After the security doors had been installed, the dispatch window was moved and is now facing the front door of our building. Family Court is scheduled to come in July to approve our plan to move the juvenile room from the basement to the old lieutenant's office.
- Meetings are moving forward with the EA School District to provide a part-time School Resource Officer, who would work out of the middle school and also cover Parkdale. The school would cover all cost of that position and retired Dare Officer/Detective Darren Longboat is being considered for that position.
- Numerous graffiti incidents were found throughout Hamlin Park in the month. In one case officers located 3 young males who used spray paint several spots in the park. They repainted those areas under the supervision of our department and their parents. Officers are currently inspecting and patrolling the park every hour, dailey.

Arrests / Investigations

- Besides the arrests and reported crimes in the above chart, Officers also investigated the following:
 - A West Falls man that we charged along with Wyoming County, Genesee County, and the Dept. of Justice, for having a sexual relationship with a teenage girl, starting when she was 12, plead guilty in federal court to transporting her across state lines for the purpose of sex. He has been in jail for the past two years and will be sentenced to 13 years in prison.
 - The department was dealing with a rash of car thefts. Organized individuals stole six vehicles and to date only one has not been recovered. The others were recovered in Buffalo. There were a couple brief attempts at stopping a couple stolen vehicles, however officers disengaged due to the dangers to the public in those situations. All of the vehicles either had a key or fob in the unlocked vehicles.
 - Officers arrested a juvenile for two robberies by force, which occurred in Hamlin Park. The individual is charged with forcibly taking money from other juveniles, on two separate dates and will be prosecuted in Family Court.
