I respectfully request approving the purchase of a Gravely Pro-Turn EV 60 SD Mower, Model #99707 with batteries. MTE Equipment Solutions Inc. of West Henrietta, NY originally quoted \$28,087.02 from the Sourcewell Contract. The dealer is offering an additional savings of \$6,088.02, bringing the purchase price down to \$21,999.

The source of funding will be A 1990 Contingent account, which has a current balance of \$40,000. However, we anticipate receiving \$10,000 from a NYSERDA Grant and proceeds from parks equipment items sold at our upcoming online auction that may cover the cost in full.
