A special meeting of the Town Board of the Town of Aurora took place on Monday, August 19, 2024, at 2:00 p.m. The Board met in-person at the Aurora Municipal Center, 575 Oakwood Avenue, East Aurora, New York.

Supervisor Snyder opened the special meeting at 2:00 p.m. The Board met to discuss and consider the purchase of an electric/battery operated riding mower and to approve applying for a grant for funds to purchase the mower.

The Town received a quote for a Gravely Pro-Turn EV riding lawn mower from MTE Equipment Solutions, Inc. in the amount of \$21,999.00. This is on Sourcewell contract #031121-ACO. Highway Superintendent Gunner anticipates receiving a \$10,000 NYSEDA grant, along with proceeds from the auction/sale of surplus Parks equipment, to be used toward the purchase price.

Councilman Wrazen moved to approve the purchase of a Gravely Pro-Turn EV 60 SD, 4 Lith zero-turn mower, model number 997007, from MTE Equipment Solutions, Inc., 33 Thuway Park Dr., W. Henrietta, NY, in the amount of \$21,999.00 off Sourcewell Contract No. 031121-ACO. Funds will be disbursed from A7110.210. Councilman McCann seconded the motion. Upon a vote being taken: ayes – four noes – none Motion carried.

Councilman Wochensky moved to approve the following budget amendment for the purchase of the Gravely Pro-Turn mower:

The Board talked about future NYSEDA funding through the Clean Energy Communities Program. Upgrading the HVAC at the Aurora Town Library was discussed, including geothermal, heat pumps/condensing units and down draft furnace. Electric vehicles were also suggested.
